

## **RCC Working Group Work Plan**

### Working Group on the Globally Harmonized System for Classification and Labelling of Chemicals for Workplace Chemicals

#### Description:

The Working Group on the GHS for Workplace Chemicals has been established to align and synchronize implementation of common classification and labelling requirements for workplace hazardous chemicals within the mandate of the U.S. Occupational Safety and Health Administration (OSHA) and Health Canada through:

- a. Making compatible their respective standards-related measures related to the implementation of the GHS and future developments in the GHS to the greatest extent practicable, without reducing the level of safety or of protection to workers recognizing their perspective regulatory processes, and
- b. Enhancing and strengthening the sharing and exchange of regulatory information between the parties related to the implementation of the GHS and future developments of the GHS with respect to workplace chemicals to reduce systematic barriers between the systems responsible for occupational safety and health of workplace chemicals.

The Working Group will meet annually.

The Task Team on the GHS for Workplace Chemicals will provide the technical support for the Working Group activities. The Task Team will meet biannually in conjunction with the United Nations Sub-Committee of Experts on the GHS.

Stakeholders will be engaged by each party twice a year as part of the preparations for the United Nations Sub-Committee of Experts on the GHS.
