The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 8,321.1 million square meter equivalents (MSME) in April 2024, an increase of 6.1 percent compared to April 2023. Imports of textiles were 6,557.7 MSME in April 2024, up 8.1 percent from April 2023. Imports of apparel were 1,763.4 MSME in April 2024, down 0.5 percent from April 2023.

Imports of textiles and apparel were 30,095.1 MSME for the year-to-date April 2024, an increase of 9.5 percent from year-to-date April 2023. Imports of textiles were 22,426.8 MSME for the year-to-date April 2024, an increase of 12.8 percent from the year-to-date April 2023. Apparel imports for the year-to-date April 2024 were 7,668.3 MSME, up 1.0 percent from the year-to-date April 2023.
