The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 8,291.0 million square meter equivalents (MSME) in May 2024, a decrease of 5.6 percent compared to May 2023. Imports of textiles were 6,327.6 MSME in May 2024, down 6.9 percent from May 2023. Imports of apparel were 1,963.3 MSME in May 2024, down 1.3 percent from May 2023.

Imports of textiles and apparel were 38,387.4 MSME for the year-to-date May 2024, an increase of 5.9 percent from year-to-date May 2023. Imports of textiles were 28,756.7 MSME for the year-to-date May 2024, an increase of 7.8 percent from the year-to-date May 2023. Apparel imports for the year-to-date May 2024 were 9,630.8 MSME, up 0.6 percent from the year-to-date May 2023.
