The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 8,359.1 million square meter equivalents (MSME) in June 2024, a decrease of 0.7 percent compared to June 2023. Imports of textiles were 6,333.4 MSME in June 2024, down 0.5 percent from June 2023. Imports of apparel were 2,025.6 MSME in June 2024, down 1.2 percent from June 2023.

Imports of textiles and apparel were 46,741.0 MSME for the year-to-date June 2024, an increase of 4.6 percent from year-to-date June 2023. Imports of textiles were 35,087.4 MSME for the year-to-date June 2024, an increase of 6.2 percent from the year-to-date June 2023. Apparel imports for the year-to-date June 2024 were 11,653.7 MSME, up 0.2 percent from the year-to-date June 2023.
