The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 9,982.2 million square meter equivalents (MSME) in July 2024, an increase of 11.1 percent compared to July 2023. Imports of textiles were 7,423.8 MSME in July 2024, up 12.5 percent from July 2023. Imports of apparel were 2,558.4 MSME in July 2024, up 7.1 percent from July 2023.

Imports of textiles and apparel were 56,718.9 MSME for the year-to-date July 2024, an increase of 5.7 percent from year-to-date July 2023. Imports of textiles were 42,505.2 MSME for the year-to-date July 2024, an increase of 7.2 percent from the year-to-date July 2023. Apparel imports for the year-to-date July 2024 were 14,213.6 MSME, up 1.4 percent from the year-to-date July 2023.
