- Mr. Chesebro Welcomed meeting participants and took roll call.

### 10:05 – 10:10 Review Meeting Goals

- Speaker: Carol Berrigan, CINTAC Chair
- Ms. Berrigan noted that the committee's Charter was coming to an end and encouraged the committee to begin final deliberations on the recommendations for the Secretary.

## 10:10 – 11:00 Briefing: TeamUSA Update

- <u>Purpose</u>: U.S. Government (USG) interagency representatives from the TeamUSA Civil Nuclear Working Group will provide updates to CINTAC on their international civil nuclear activities
- Speakers:
  - Lauren Joyce, Chief of Staff & Senior Policy Advisor, Office of International Nuclear Energy Policy and Cooperation, U.S. Department of Energy
    - Ms. Joyce noted that the Uranium ban was signed by the President on 5/13. The law comes into force 90 days after that date. The current waiver process is in place. She noted that for industry there could be increased fuel cost and encouraged domestic enrichment to offset this issue.
  - Kirsten Cutler, Senior Strategist for Nuclear Innovation, Bureau of International Security and Nonproliferation (ISN), U.S. Department of State

Ms. Cutler noted that following the signing of the Uranium ban the Department of State issued a démarche for 100 countries encouraging them to put in place a similar policy. She also noted that the Department's NEXT program is soliciting applications from Eastern Europe and Western Asian nations. The program offers project prep tools for those nations looking at SMR options. Companies can respond to the Public Notice that listed on January 1.



- Randy Howell (NRC)
   Mr. Howell noted that while the NRC has regulatory independence, they try
  to follow the administration's policy guidance on prioritizing nations. NRC
  is focusing on regulatory cooperation with Great Britain and Canada.
- Carl B. Kress, Regional Director, Middle East, North Africa, Europe and Eurasia, U.S. Trade and Development Agency
   Mr. Kress highlighted the event at Oakridge National Lab in
   Tennessee, on October 7. He noted this was the first of a series. The
   next workshop will be in Turkey, and then a workshop on Ukraine
   held in Poland. Beyond that they are looking at Bulgaria as a final
   site.
