The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 10,430.5 million square meter equivalents (MSME) in September 2024, an increase of 24.3 percent compared to September 2023. Imports of textiles were 7,811.7 MSME in September 2024, up 29.7 percent from September 2023. Imports of apparel were 2,618.7 MSME in September 2024, up 10.6 percent from September 2023.

Imports of textiles and apparel were 76,860.8 MSME for the year-to-date September 2024, an increase of 8.8 percent from year-to-date September 2023. Imports of textiles were 57,526.5 MSME for the year-to-date September 2024, an increase of 11.0 percent from the year-to-date September 2023. Apparel imports for the year-to-date September 2024 were 19,334.3 MSME, up 2.6 percent from the year-to-date September 2023.
