The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 10,673.7 million square meter equivalents (MSME) in October 2024, an increase of 33.1 percent compared to October 2023. Imports of textiles were 8,220.4 MSME in October 2024, up 37.2 percent from October 2023. Imports of apparel were 2,453.2 MSME in October 2024, up 21.0 percent from October 2023.

Imports of textiles and apparel were 87,528.7 MSME for the year-to-date October 2024, an increase of 11.3 percent from year-to-date October 2023. Imports of textiles were 65,742.8 MSME for the year-to-date October 2024, an increase of 13.8 percent from the year-to-date October 2023. Apparel imports for the year-to-date October 2024 were 21,785.9 MSME, up 4.4 percent from the year-to-date October 2023.
