The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 9,992.1 million square meter equivalents (MSME) in November 2024, an increase of 43.3 percent compared to November 2023. Imports of textiles were 8,057.9 MSME in November 2024, up 51.3 percent from November 2023. Imports of apparel were 1,934.2 MSME in November 2024, up 17.5 percent from November 2023.

Imports of textiles and apparel were 97,516.5 MSME for the year-to-date November 2024, an increase of 13.9 percent from year-to-date November 2023. Imports of textiles were 73,797.7 MSME for the year-to-date November 2024, an increase of 16.9 percent from the year-to-date November 2023. Apparel imports for the year-to-date November 2024 were 23,718.8 SME, up 5.3 percent from the year-to-date November 2023.
